Leak Sensor

Thank you for purchasing the DOME Leak Sensor, which works with your Z-Wave Certified Controller to monitor your home for leaks and for rising water levels in your sump pump.

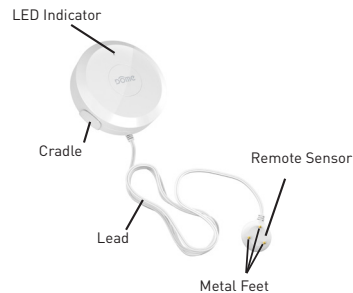


Figure 1 - Leak Sensor Front

Including/Connecting into the Z-Wave Network:

Follow the instructions for your Z-Wave certified Controller to enter inclusion mode.

When prompted by the Controller:

1. For proper inclusion, bring the Leak Sensor to within 10 feet of your Controller. After inclusion, the device can be moved to any desired location.
2. Remove the cover of the Leak Sensor by twisting it apart (Fig 3.)
3. Remove the Battery Tab.
4. Press the Connect Button quickly 3 times in a row.

The LED Indicator will flash five times indicating inclusion.

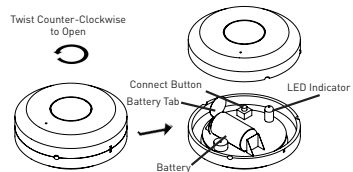


Figure 2 - Opening the Leak Sensor

Excluding/Disconnecting from the Z-Wave Network:

Follow the instructions for your Z-Wave certified Controller to enter exclusion mode.

When prompted by the Controller:

1. Remove the Cover of the Leak Sensor.
2. Press the Connect Button quickly 3 times in a row.

The LED Indicator will flash five times indicating exclusion/disconnection.

Resetting the Leak Sensor to Factory Default Settings:

To disconnect from the Z-Wave Network and restore factory default settings:

1. Open the Back Plate and make sure the Leak Sensor is powered.
2. Hold the Connect Button for 10 seconds until the LED Indicator blinks once, then release the button.

Only do this if the controller is disconnected or otherwise unreachable!

How to Use—Without Cradle:

You can use the Leak Sensor to monitor most appliances and pipes for leaks without the cradle. Once included in your Z-Wave system, place the Leak Sensor on a flat surface near the item you want monitored where water will collect if it leaks. Make sure all three Metal Feet are touching the surface.

When water contacts the Metal Feet, it will beep and send an alert to your Z-Wave Controller notifying it of the detected water.

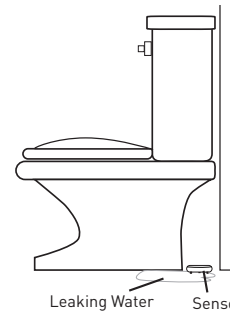


Figure 3 - Using the Sensor Without the Cradle

How to Use—With Cradle:

To use the cradle, place the sensor into the Cradle, making sure the Metal Feet make full contact with the Metal Contacts. It can be placed on a surface or mounted on a wall using the included hardware. The Remote Sensor Probe plugs into the Cradle through the 3.5mm minijack.

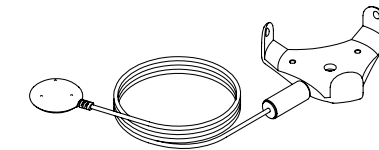


Figure 5 - The Cradle

How to Use—Installing with the Cradle and Remote Sensor:

To use the Leak Sensor in hard-to-reach areas, mount the Cradle on a nearby wall and place the Remote Sensor in the area you want monitored. Make sure the sensor is laying flat with its Metal Feet making full contact with the floor or surface.

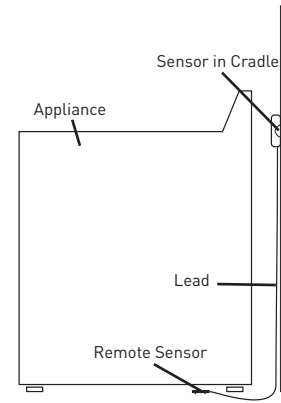


Figure 6 - Using the Remote Sensor

How to Use—Installing with the Cradle and Remote Sensor:

To monitor the water level in your sump pump pit, mount the Cradle on a nearby wall and suspend the Remote Sensor in the pit 5 inches below the lid. Suspending the Remote Sensor in the pit allows you to get a notification before the water starts to overflow the pit.

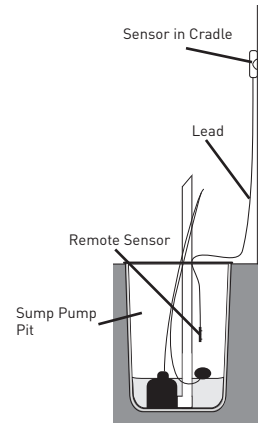


Figure 7 - Using the Remote Sensor in a Sump Pump
